Subject: 2025 Budget – Additional Information (March 7, 2025 Council Meeting)

Purpose:

The purpose of this report is to provide updated information regarding the changes that have been made, to date, by Council, to the draft 2025 Budget.

Recommendation:

That any items requiring follow-up action be considered through an appropriate resolution of Council.

Background:

During Council's budget review sessions, on January 7, 2025, and February 6, 2025, several motions were approved to effect changes to the draft 2025 Operating and Capital budgets as presented by staff. Details on those adjustments are included in this Report.

Financial Impact:

There is no financial impact associated with the receiving of the information in this Report. If follow up action is considered, in the form of a resolution of Council, after receiving the information, these resolutions may affect the 2025 municipal tax rates, or the content of the Capital Budget, for HBM.

By-law Number 2025 - 016
